

PRIVACY STATEMENT AND INFORMATION ON COOKIES

The provision of data is voluntary. If you provide us with the required data, you allow the website operator to process such data exclusively in order to respond to the user email.

The operator also takes the obligation not to disclose the personal data obtained by it to third parties under any circumstances.

Purpose of processing: establishing contact

Legal basis of processing: Section 5 (1) (a) of the Act CXII of 2011 on Informational Self-Determination and Freedom of Information; Data subject's consent

Cookies

On our Experidance.hu website we make anonymous statistics about visitors' habits, using cookies.

Cookies are the means of information exchange between the web server and the user's browser. These data files cannot be run; they do not contain spyware and viruses, and they cannot access the content of the users' hard drive.

The cookies used on our Experidance.hu website collect web statistics information such as which sites have been visited by the user or which website parts have been clicked on by the user. With the use of cookies, Experidance.hu neither collects nor stores data enabling personal identification. Therefore, these cookies cannot identify you personally.

Essential session (session-id) cookies:

The use of such cookies is essential to be able to navigate on the website and to ensure the operation of website functions. Without agreeing to the use of such cookies, the website or its particular parts may not be displayed or may be displayed incorrectly.

Analytical or performance monitoring cookies:

Such cookies help us differentiate between the website users and collect data on the visitor's behaviour on the website.

The data are processed for 26 months following the visit to the website.

Enabling and blocking cookies

The user may block processing performed by cookies. If cookies are blocked, however, the website or any content or services available on the website may not be accessible or their availability may be limited.

If the user refuses to consent to the placement of cookies, he or she may do so via the settings (blocking, withdrawal) in its own browser.

Legal remedies

Period of processing: in compliance with the current legislation.

The user may request information on the processing of his or her personal data, as well as the rectification or erasure – with the exception of processing activities specified by law – of his or her personal data in the way indicated upon data recording or at the following contact points of the Controller:

Upon the data subject's request, the operator as controller shall give information – in writing, upon the data subject's related request – on the data processed by it or by the processor engaged by it in the shortest possible time following the submission of the request but no later than 30 days, using plain language. Such information shall be free if the person requesting the information has not submitted a request for information to the controller in the current year with regard to the same set of data. In other cases, the operator shall specify reimbursement.
